## Coronavirus (COVID-19) Acknowledgement and Waiver

Dear Client,

We are grateful for the opportunity to serve you. In these uncertain times we are taking every reasonable measure to protect against the spread of Coronavirus (COVID-19). This Acknowledgement and Waiver (this "Agreement") is for the purpose of informing you of our commitment to maintaining health and safety, to obtain your acknowledgement of required public health and safety measures and a waiver against holding us or our related parties responsible for any COVID-19 infection you or your related parties (or anyone claiming through you or them) ("Client") may suffer during or after the period in which we, Yoga Energy Studio, TruFitness Inc., and TRGanley Corp. are rendering services to you.

Client acknowledges that Yoga Energy Studio, TruFitness Inc., and TRGanley Corp. have taken certain steps to implement protocols issued by Public Health Authorities for slowing the transmission of COVID-19. In accordance with the most recent protocols, Client represents that neither Client nor any other person with which Client has come in contact has tested positive for COVID-19 in the past 14-days, has recently been exposed to any person who has tested positive for COVID-19 and has no symptoms associated with COVID-19. In addition, for so long as Yoga Energy Studio, or TruFitness Inc., or TRGanley Corp. are rendering services to the Client, Client shall immediately advise us if Client or any person with whom Client comes in contact in the future (i) is diagnosed with COVID-19, (ii) comes in contact with a person who is diagnosed with COVID-19, or (iii) exhibits symptoms associated with COVID-19. Client shall take all appropriate actions to adhere to personal hygiene guidelines and guidelines prescribed by Public Health Authorities.

In further consideration of having Yoga Energy Studio, or TruFitness Inc., or TRGanley Corp. render services to the Client, Client covenants not to sue Yoga Energy Studio, or TruFitness Inc., or TRGanley Corp. their directors, officers, employees, contractors, franchisors and their representatives and agents (together, the "YES Parties") and releases, waives and discharges the YES Parties from all liability to Client for any loss or damage, and any claim or demands on account of any injury to, or an illness or the death of, Client or any third party related to COVID-19, whether caused by the negligence of Yoga Energy Studio, or TruFitness Inc., or TRGanley Corp. whether known, or unknown, suspected or unsuspected which now exists or did exist, or otherwise while or after Yoga Energy Studio, or TruFitness Inc., or TRGanley Corp. are rendering services to the Client. Client further agrees to indemnify and save and hold harmless the YES Parties, and each of them, from any loss, liability, damages or costs that they may occur, whether caused by the negligence, active or passive, or otherwise of Client. Client further agrees that this Agreement is intended to be as broad and inclusive as possible and that if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect.

Client has carefully read and fully agrees to this Agreement. Client is aware that they may be giving up valuable legal rights, including the right to seek to recover damages from Yoga Energy Studio, TruFitness Inc., and TRGanley Corp. in case of illness, injury or death from exposure to COVID-19.
